PRIMARY INVESTIGATION DETAILS : 1 Immediate action

1. CAD 8209/31DEC12 attended by K4N KG305N crewed by PC BARNABY 737KG and PC MCDONALD 864KG PC LOVE-TAYLER 698KG and PC O'KANE 609KG

2. Police received a call from the victim stating he had been sexually assaulted by a MALE the previous night and he was now on scene at the Barking Dog Public House. On arrival police spoke with [X1] who stated that his ex partner PORT had given him poppers and alcohol the previous night and then had anal sex with him against his will. [X1] stated that PORT kept plying him with poppers and alcohol each time he refused to have sex with him until [X1] was unable to say no.

The couple have been in a relationship with each other for approximately 2 years. they do have a sexual relationship in which they do have consensual anal sex. However [X1] states that on a few occasions he has felt pressured into sexual activity and that this is not the first time PORT has used drugs and alcohol to "take advantage" of [X1]

He stated that the incident last night took place in the living room area of PORT's home address. [X1] had visited the address with the intention to have a drink watch a film and spend the night but he had not intended to have sex on this occasion.

Whilst being dealt with by police [X1] was very highly emotional and stated that he wished to slit his throat. he also stated that he could hear voices and wanted to die. He began to punch out at objects and asked police to handcuff him for his own protection. Due to his agitated state he was handcuffed and taken out to the police car to speak to him. [X1] was so highly emotional that he

was having trouble breathing. Officers were unable to gather information regarding what [X1] was wearing at the time of the incident. He stated he had showered since as he had got washed and dressed prior to visiting his parents grave earlier in the day.

PC MCDONALD spoke with [X1] friend [Name Redacted] who stated that [X1] is prone to emotional outbursts. He explained that new years eve is the anniversary of [DPA] death and that [X1] was sexually abused by [DPA] when he was [a child]

Due to [X1] mental state and the fact that he was asking police to take him somewhere he couldnt hurt himself he was sectioned under S136 and taken to [DPA] hospital. Officers were not able to get a first account from him.

PC O'KANE spoke with PORT who stated they had been in a long term relationship and said "let me get him home he'll be fine in an hour. He's been drinking gin and it always sets him off."

PC O'KANE arrested PORT who was present at the pub. His reply to caution was "I understand you are welcome to look at my phone see the messages from him that he loves me. his clothes are at my house."

X1 confirmed as he had stated on the phone that he did not wish to pursue this matter and provided us with the following withdrawal statement:

On Monday 31st December 2012 I was in the Barking Dog Public House in Barking with my friend Stephen Port.

I have known Stephen for two months and I met him on a gay website called Badoo.

We had only been in the pub an hour when we had a heated conversation regarding problems in our relationship, stemming from demands Stephen makes on me.

I was feeling stressed, I don't like New Year and was just waiting for it to pass. Stephen continued making verbal demands and I began to feel suicidal.

I went to the toilet and hit a wooden door with my right fist. I tried to calm down but couldn't. The situation got more intense and then the police arrived.

I spoke to a male officer and explained how I felt with regards to my emotions and the pressures I was feeling from Stephen. I also told him Stephen was forcing me to do sexual acts I wasn't comfortable with.

By forcing me I mean that he would encourage me to drink large amounts of alcohol to get me started for poppers. He would then give me poppers to sexually arouse me. I wasn't comfortable with this at all but I didn't say anything because I was scared in many ways about how he would react.

Stephen would not have known that I did not want to do these sexual acts, as I never said anything to indicate this, but I didn't.

I have spoken to officers from the Sapphire Unit. They have explained their role to me and the role of the unit. They have also explained the options available to me.
