
I have spoken to Sarah SAK (Victims Mother) tonight. I introduced myself and stated I would be her family Liaison Officer. I explained my role to her and she understood. I updated her telling her that the special post Mortem had been completed and we were awaiting results from the Coroners Office. I stated I could not give her any time scale at present but explained the coroners process to her and that they would be making every attempt to release Anthony's Body ASAP. I explained that we are treating his death as unexplained but at this time not suspicious and explained that she would be kept updated with the investigation.

I provided her with a mobile number, landline and explained that I would also email her so she can contact me if she has any questions. I explained that I am not on duty 24 hours so if I did not answer I would make every effort to contact when I was on duty. I explained that I had liaised with Thomas (Victims Father). I confirmed that she is happy for me to provide Anthony's friend her with updates and information on the progress.

Sarah's main concern at this time is when Anthony's body will be released so they can arrange for him to be taken back up to Hull for the funeral. Sarah not sure if she will travel down to London to view the body. I explained about the Cremation act and she is not sure what she wants to do at present.

Sarah states her and Anthony were like best friends they would talk most days on the phone and knew about what each other were doing. She was in the process of moving to Essex to be closer as she only saw him a few times a year, the last time being in March where she visited him. She states he liked to drink and she knows he would dabble with drugs she thinks cocaine. Sarah states she knew he was gay and has known since he was twelve. But states his dad didn't know. Sarah states Chia is his best mate and she has had contact with his friends today. She states China will help police with items in Anthony's flat.

I asked if she had any questions she wanted answers to how Anthony was identified and asked if it was by his teeth. I said that I would find out for her and let her know,

I said to Sarah that if he feels like he is struggling with this he may need to go and see his doctor. I said I would also try and provide him with some details of support agencies if he required these now and in the future.

She did not have any more questions and was satisfied with what I have explained. I stated I would let her know at this time if there were any updates and would make attempts to call her next week.
