On THURSDAY 28th AUGUST 2014 I was on duty in full uniform with PC HOLMES 911KG. At around 0900 a call came over the radio CAD 2086 REFERS, a member of public had found a male on the floor who she believed to be dead. I attended the scene with PC HOLMES 911 KG and arrived at 0915hrs, PC HALL and PC GUTHERIES were also on scene. I now know the member of public to be Barbara DEWHAM who contacted police she explained she had been walking her dogs; she came across him and called police. I went and stood at a side gate to look out for LAS and other units attending. I was told to stay at this entrance as the scene was now being treated as a crime scene. I remained there until 1010hrs when I was asked by PC HOLMES to come and assist and other officers had arrived to take over the cordon control. I assisted PC HOLMES check the property and was asked to bag the property, and take it to custody. DC DESAMI, DC GARRATT and DS SWEETMAN left the scene at 1045hrs. PC HOLMES informed me to wait for the photographer, once they had been contact KG5 and then the coroner. PC HOLMES informed me LAS K102 pronounced life extinction at 0927hrs the body was searched at 0935hrs by himself and PC HALL. PC HOLMES left at 1220hrs. At 1150 SOCO CSE261 attended the scene took photos and left at 1300hrs. KG5 were contacted and I called support to speak to the coroner. At 1330hrs I spoke to the coroner Theresa STEANMAN and updated her with the information passed onto me from PC HOLMES. I was informed undertakers would be at location in the next hour and a half and the body would be taken to QUEENS HOSPITAL. At 1435hrs Ray RUSSELL and Mark WALTERS working on behalf of CO-OP undertakers arrived and took the body informing me they were taking the body to QUEENS HOSPITAL. The undertakers left the scene at 1453hrs. At 1500hrs I left the scene I took the property to FRESHWHARF and booked it into custody 66/8773 One suitcase with personal items clothes and cosmetics 105/1391, One bottle of VODKA exhibited TGF01 105/1392, Medication exhibited TGF02 105/1393, One passport and two letters exhibit TGF03 105/1394, Sim card TGF04 105/1395, Correspondences TGF05 105/1396, Personal Items TGF06 105/1397, Sunglasses TGF07 105/1398. With in the medication was One packet of IBUPROFENE ratiopharm 14 tablets in packet 400mg, KLACID SR clarithromycinum 7 tablets in packet 500
