Jules,

An update as requested. Situation still fluid as we await developments.

- At 0418hrs, LAS called to a male apparently deceased o/s a block of flats in Cooke St, Barking (nr Town centre).
- Caller has been identified (believed to be a resident of the block). Police to debrief him
- male found slumped on pavement. He has apparent facial injury (thick/cut lip). Also had apparent footprint visible on his abdomen ****the latest from the scene is that this may not be a footprint but internal blood drainage site****
- death is being treated as "unexplained" at this time.
- BOCU have ownership at this time. T/Supt Hamer leads. This will be reviewed.
- Victim in possession of a passport and his believed identity is Anthony Patrick Walgate, 08/05/91, Born Hull. He is a white male.
- Initial scanning shows only minor convictions. last in 2010. also some reference to self harm in 2010. Intel continues.
- NOK not yet identified/informed.
- initial flash search conducted - negative. CAD checked but nothing apparently linked.
- CCTV enqs ongoing, although most proximate LBB camera defective.
- House-to-house underway.
- Scene being managed by CSM. KG 1 and SC&O1 present. requires 7 officers/PCSOs which BOCU can manage.
- No MPS vulnerabilities identified at this stage. KG initial response good.
- Community impact being assessed. Nothing on social media/community KINs at this time. To be reviewed throughout the day
- initial media lines agreed and being shared/Tweeted. This includes a witness appeal.
