He meet Gabriel KOVARI on 14th July 2014 via a dating web site app known as Bender. They meet and remained friends. He mentioned that he was looking for accommodation to rent. John states that he was thinking of renting out his spare room. They meet at the hostel Gabriel was staying at "The Great Eastern Hostel" which was on the Isle of Dogs. Gabriel had just got a job in a Slovankian Shop in Richmond. Gabriel told John that if he could not find anywhere to stay he would sleep in peoples gardens. John was aware that Gabriel was a young gay male wanting to make a life for himself in

The special post mortem yielded swabs and samples, which can be used to follow up any further enquiries as necessary, and comprehensive photographs have also been taken.

In all likelihood the potential benefit of retaining the body is outweighed by the distress caused to the family by further retention.

She stated that it was normal procedure for them to re dress the victim in suitable clothing and take them back to their country. I then contacted Roland Brothers International Funeral directors 0800 917 3585 who are based in Croydon. Eugenia informed me that the body was collected and that he was undressed. She said that this was normal quite often the clothing is so dirty that it is disposed of. Therefore we do not have the clothing he was found in.
