Hi Rolf,

In short, it is best not to release the body to the family as there are still not enough answers for all concerned to be satisfied regarding the cause of death. My advice is await the results of the toxicology as if it turns out to be an unlawful killing of some kind there is potential for more work to be done. Also, if it is an unlawful killing and a suspect is identified, or if the coroner is not happy for some reason, there will be a 2nd post mortem carried out.

This will be a difficult message for the family but as the death remains un-explained there is a need for us to be cautious, follow protocol and not miss any opportunities to enable us to fully understand how Daniel died. However, your DCI / Supt and the coroner may have a slightly different view.
