From the CRIS updates the following actions below seem to have now been completed. Do you now think we are in a position to authorise body release as the family are getting anxious.

- LBBB CCTV has been viewed, the cameras are not clear enough to identify anyone, also majority of cameras are very busy with people. With out a more exact time I do not think these camera will be of any use, even with a more exact time I feel it will be difficult to establish Daniel on the camera. The hard drive has been seized from the church and is with Newlands park again I am not sure this camera will be of much use with out a more exact time.

- Statements taken from Ricky Waumsley (Whitworths Partner), John Pape (Kovari's Old Flat Mate), Daniel O Connell (Work Colleague caught train with him on the Thursday) and Barbara (dog walker who found both Whitworth and Kovari)

- We are in possession of Whitworths work Rota, sickness record and holidays.

- From information provided by PAPE Kovari left his flat with all his belongings over a week before he was found dead by police so no search completed as no belongings of Kovaris left in flat.

- Target date for Toxicology results for Kovari and Whitworth is the 15/01/2015 which is some way off.

- Phone work was completed on Whitworths phone for up to a week prior to his death and we have that information. I have requested that we go back a bit further and awaiting answer from SPOC.
