Police were called by Informant who stated that she had found a young white male in the church yard and she believed him to be dead.

Police attended the location a Graveyard to St Margaret's Church, North Street Barking and after a brief search of the ground located the informant and the VIW. The VIW was leaning up against the back wall of the enclosed grave yard in the left and corner, he was slumped over to his left side, dressed in a light blue hooded top pulled up at the front and navy/ black jeans, wrapped partially in a dark blue bed sheet in his left hand was a white piece of paper in a clear plastic sleeve. In between the subject's legs was a 2ltr Tesco Cola bottle with liquid in it and a whole T-shirt. Under his legs was a black place matt that would normally be found on a dining table.

Sticking out of the subjects left jean pocket was a small brown glass bottle with a cap that contained a small amount of unknown liquid.

The subject's body was cold to the touch and he was unresponsive and appeared to have been in this condition for some time due to how cold he was to the touch.

Paramedics attended the scene and subject's life was pronounced extinct at 11:45hrs by LAS Calls sign K250. Coroner Jayne DAY at Waltham Forest Informed.

PC BROWN 565KG and PC YEXLEY 513KG checked the victims body, there were no obvious injuries or marks on the subjects body that would give cause for officers
